1 Drug Addiction – led by Billy Thomas


For the past 24 years Billy Thomas has worked with Merrill Lynch in Cary, NC. He began his halftime journey in 2016 joining a Roundtable in Raleigh. God led Billy's family to take action. He and his wife, Lisa, opened a safe house for men coming out of detox. So far over 80 men have come through the house, and they're in the process of establishing a safe house for women. He loves seeing lives transformed.



2 Sports Ministry – led by Brad Bradley



Brad is involved today with Sports Friends (<u>www.sports-friends.org</u>), a ministry of SIM. Sports serve as a powerful and effective tool for building relationships and sharing the gospel. Through relationships first built on the sports field, Sports Friends-trained coaches from the local Church are bringing hope to youth and their families. Much more than a sports coach, these "life coaches" are mentoring and loving young people, leading them to Christ and helping them walk as mature disciples of Jesus. By God's grace, lives are being transformed, new churches established, and entire communities strengthened!



Mark owns a successful precast concrete company in Charlotte. Mark came to know Jesus through Joe Gibbs. He and Joe have partnered to bring Joe's "Game Plan for Life" program into prisons in North Carolina. Today Mark blends his time between his fast-growing company and an innovative program providing seminary training to people in prison for life – equipping pastors inside our prisons to help transform the lives of inmates. His dream is that those who leave prison will stay out and be healthy enough to lead meaningful, joy-filled lives. 4 Financial Literacy – led by William Sloan






7 Strategic Philanthropy – led by John Putnam
